#### **TERMS & CONDITIONS (T&C):**

#### 1. Minimum Qualifying Requirements:

- a. The firm/bidder should be authorized Network Service Provider (NSP)/ Internet Service Provider (ISP) registered in Nepal for past 5 Years.
- b. The Internet Service Provider (ISP) shall be capable of providing 25/25Mbps Internet Connectivity Bandwidth at SAPDC, Powerhouse site Kerabari Sankhuwasabha, Nepal via optical fiber with contention ratio of 1:1 & 97% guaranteed uptime on Internet (besides the local loop) and with no restriction up to subscribed speed and unlimited data usage volume.

#### 2. Submission of Bid:-

The bidder must submit the bid in the following two separate sealed envelopes {PART-I (Envelope-1) & PART-II (Envelope-2)} clearly indicating the contents therein duly super scribed as under and these two envelopes should be enclosed in a single sealed envelope/cover super scribed as "Procurement of Internet Connectivity service via optical fibre at Power House Site, Phukhuwa and Guest House Kherawari for Two (02) years (PPR-200/2024)" and submitted at the address of the undersigned and must reach this office through courier or by post or by hand on or before 15.01.2025 by 1530 Hrs. and same shall be opened on 15.01.2025 at 1600 Hrs. in presence of authorized representative of firms who choose to attend.

Further, In the "Techno-Commercial" part {i.e in PART-I (Envelope-1)} of the bid the bidder shall not give any indication about the bid price in any manner whatsoever. Non-compliance of this provision may result in the rejection of bid.

#### 3. Opening of Bid:-

- 5. **Completion period:** Completion period for installation shall be 30 days to be reckoned from date of issuance from Letter of Acceptance (LOA) or as per instruction from EIC/his representative complete in all respect as per scope of work.

The contract period shall be for two **(02) years** from the start date of internet connectivity provided by the firm. SAPDC reserves the right to extend the contract for another one **(01)** year on same rate and term & conditions subjected to satisfactory performance certificate from EIC or his representative.

However, if the internet service is not found satisfactory, SAPDC also reserve the right to cancel the contract with one month notice to the contractor/internet service provider (ISP).

6. **Bid Validity:** The bid (s) shall be valid for 90 days from the opening of bid(s).

#### 7. Prices:-

- i. The Bidder/Suppliers shall offer rates & prices "on Firm Price Basis". The quoted rates for item(s) shall be including TSC and VAT complete in all respect as per scope of work.
- ii. Rates and Offered discount (if any) should be filled in both figures and words. In case of ambiguities in between the rate/ Offered discount in figures and the rate/ Offered discount in words, the rate/Offered discount quoted in words shall prevail and the amount shall be corrected accordingly. The SAPDC reserves the right to adjust arithmetical or other errors in any tender/quotation in the way which it considers suitable.
- iii. Further, only unconditional discount offered at appropriate place in the BOQ shall only be considered for evaluation of the bid, discount offered at

- any other place or in any other document/letter submitted by the bidder along with the bid shall not be considered for the purpose of evaluation as well as award.
- **iv.** The percentage (%) offered discount should preferably be filled in both figures and words. However, if bidder do not choose to offer any discount on their quoted rate(s) i.r.o any/all item(s) of Bill of Quantities (BOQ) at Annexure-A, then the bidder may mention the same as **Nil**.
- 8. **Payment:** The payments will be made in the following manner:

#### 10. Award Criteria:

The bid shall be evaluated on overall basis and the award shall be made to the Firm(s)/Agency(s) who has offered the lowest evaluated bid price (Ref. Annexure-A) for whole work as per Scope of work (Ref. Annexure-B) provided the evaluated Bid Price is within a reasonable variation of the estimated amount of Work.

#### 11. Liquidated Damages (LD)/Penalty:

i. In case of link failure, supplier will fix the problem within 6 hours after SAPDC reports the problem. If the problem persists for more than 6 hours, SAPDC shall deduct one day's charge from the monthly recurring bill. If

- subsequent link failure exceeds more than 12 hours, every 12 hours is considered for 1 day charge deduction.
- ii. On failure of installation of internet connection within 30 days from the date of intimation by EIC or his authorized representative, LD @ 0.67% of total contract price shall be levied per day subjected to maximum of 5% of contract price.
- iii. In case supplier fails to install internet connection and maximum limit of 5% LD is exhausted, SAPDC reserves the right to terminate the contract on immediate basis and BG/Security money shall be forfeited and supplier shall be barred from participation in SAPDC tenders for one (01) year.

#### 12. Performance Security Deposit:

- 12.1 Within 28 (twenty-eight) days from the date of issue of the Letter of Acceptance (LOA), the successful bidder(s) shall deliver to the Employer a Performance Security equal to **5% (Five percent)** of the Contract Price valid till 60 days beyond Contract period.
- 12.2 The Performance Security Deposit shall be in the form of a demand draft / Banker Cheque in favor of "SAPDC-NPR Construction Account" payable at Khandbari/FDR (duly pledged in favor of SJVN Arun-3 Power Development Company Private Limited (SAPDC)/The bidder may submit the same in the form of irrevocable, valid and fully enforceable Bank Guarantee in favor of SJVN Arun-3 Power Development Company Private Limited (SAPDC) in the prescribed form (Ref Annexure-II) from a Class A bank situated in Nepal acceptable to SJVN Arun-3 Power Development Company Private Limited.
- 12.3 Failure of the successful Bidder to comply with the requirements of Clause 12.1 shall constitute sufficient grounds for cancellation of the award and forfeiture of the Earnest Money Deposit. He may also be debarred from participating in bids invited by the Project for one year.
- 12.4 The performance guarantee will be returned by the EIC (Engineer-in-Charge)/Officer-In-Charge (OIC) to the contractor/Supplier within 28 days after completion of contract without any interest, after issuance of successful Completion Certificate.
- 12.5 In case of delay in submission of performance security beyond 28 days as provided in clause 12.1 above, interest @ SBI, India one year MCLR +200 Basis points applicable on the date of bid submission shall be charged on per day basis up to the date of delay in submission. However, delayed acceptance beyond 56 days shall be at the sole discretion of SAPDC and Letter of Acceptance/ award (LOA) shall be subject to cancellation and forfeiture of EMD along with other suitable action as per NIQ.
- 12.6 In case, the last day of submission of Performance Security happens to be a bank holiday, the last day of submission shall be the next working day.
- 12.7 The notification of Award (NOA)/Letter of Acceptance (LOA) will constitute the formation of the Contract and further subject only to the furnishing of a performance security.

13. **Force Majeure:** The term "Force Majeure" shall herein mean riots (other than among the Vendor's employees), Civil Commotion (to the extent not insurable), war (whether declared or not), invasion, act of foreign enemies, hostilities, civil war, rebellion, revolution, insurrection, military or usurped power, damage from aircraft, nuclear fission, acts of God, such as earthquake (above 7 magnitude on Richter Scale), lightning, unprecedented floods, fires not caused by Vendor's negligence and other such causes over which the Vendor has no control and are accepted as such by the Officer-in-Charge (OIC), whose decision shall be final and binding. In the event of either party being rendered unable by Force Majeure to perform any obligation required to be performed by them under this contract, the relative obligation of the party affected by such Force Majeure shall be treated as suspended for the period during which such Force Majeure cause lasts, provided the party alleging that it has been rendered unable as aforesaid, thereby shall notify within 10 days of the alleged beginning and ending thereof giving full particulars and satisfactory evidence in support of such cause.

Extension of time without levy of LD shall be provided during the period of occurrence of Force Majeure event, however no cost compensation shall be provided.

- 16. **Resolution of Dispute:** In case of any dispute or difference that arises out of the subject cited supply, the same shall be referred to the Sole Arbitrator, who shall be appointed by the CEO, Arun-3 HEP, SAPDC, Tumlingtar. The award of the arbitrator shall be final and binding on both the parties.

Courts of Chainpur (Nepal) shall have exclusive Jurisdiction for adjudication upon the dispute arising out of the subject cited supply between the parties.
