TERMS & CONDITIONS (T&C):

1. Minimum Qualifying Requirements:

- a. The firm/bidder should be authorized Network Service Provider (NSP)/ Internet Service Provider (ISP) registered in Nepal for past 5 Years.

In case of link failure, Supplier will fix the problem within 6 hours after SAPDC reports the problem. If the problem persists for more than 6 hours, SAPDC shall deduct one day's charge from the monthly recurring bill. If subsequent link failure exceeds more than 12 hours, every 12 hours is considered for 1 day charge deduction.

12. Performance Security Deposit:
