Deptt. /SAPDC during the last 03 (three) years on grounds of corrupt/fraudulent practices and/or on any ground. 2. Bidder Eligibility Criteria/Qualifying Requirements:

- 8. SAPDC reserves the right to adjust arithmetical or other errors (if any) noticed in the quotation as follows:

12. Liquidated Damages (LD)/Penalty:

In case, movement is cancelled after confirmation from the service provider, the security deposit of the agency shall be seized/forfeited. The empanelment/rate contract of the agency shall be considered for termination.

13. Performance Security Deposit:

- 13.1 Within 28 (twenty-eight) days from the date of issue of the Letter of Acceptance (LOA), the successful bidder(s) shall deliver to the Employer a Performance Security of **NPR 1,00,000/-**.

16. **Resolution of Dispute:** In case of any dispute or difference that arises out of the subject cited supply, the same shall be referred to the Sole Arbitrator, who shall be appointed by the CEO, Arun-3 HEP, SAPDC, Tumlingtar. The award of the arbitrator shall be final and binding on both the parties.

Courts of Chainpur (Nepal) shall have exclusive Jurisdiction for adjudication upon the dispute arising out of the subject cited supply between the parties.

The contract shall be governed by and interpreted in accordance with the laws in force in Nepal.

17. Integrity Pact (Schedule-F):

To improve transparency and fairness in the tendering process, SAPDC is implementing Integrity Pact To improve transparency and fairness in the tendering process the Employer is implementing Integrity Pact. Integrity Pact is deemed as part of the contract so that the prospective bidders are bound by its provisions.

1.0 SCOPE OF WORK:

- i. Provide helicopter services on a need/requirement basis for VVIP/VIP Visits at sites, emergency or any other specified purpose.
- ii. Services shall be provided as per instructions issued by the employer/SAPDC during the empanelment/Contract period.
- iii. Service provider shall provide Helicopter with Twin engines and minimum 05 person seating capacity as and when required basis. However, in case of non-availability of Service provider with Twin Engine Helicopter, Helicopter with 1 engine and minimum 05 person seating capacity may be empaneled.

- 2. Considering the high altitude and safety aspects, the Helicopter should be of preferably dual engine and have the capability to land on temporary helipads available in high altitude areas in Nepal.
- 3. Service provider shall provide Helicopter with Twin engines and minimum 05 person seating capacity as and when required basis. However, in case of non-availability of Service provider with Twin Engine Helicopter, Helicopter with 1 engine and minimum 05 person seating capacity may be empanelled/hired.
- 4. The service provider must have license to operate such services in the territory of Nepal along with any certification, if required from appropriate authority. The agency must have ownership of Helicopter or have lease agreement with the owner. Agency must have the trained pilots with license/Qualification (CPL/SPO) to operate the helicopter in Nepal as per CAAN regulations.
- 5. It will be the responsibility of the agency for insurance of aircraft/air crew, passengers and third party damage. Further, the Insurance policy should have provision for Insurance cover for no fault liability in case of CRASH of helicopter.
- 6. Heli service operator shall be liable for Risk and liability during the service and SAPDC shall not be responsible for any loss or liability arises for operation or services of SAPDC
- 7. Since the helicopter will fly in high altitude area, it should have the facilities of oxygen for the comfort of passengers.
- 8. The contract will be initially for one year but extendable for further period on mutual agreed terms & conditions. However, SAPDC, reserve the right of terminating contract in case of any breach to contractual obligations.
- 9. The operator must follow a Safety Management System (SMS) in line with ICAO/CAAN standards.
- 10. The Service provider should ensure that Aircraft/Helicopter should be airworthy in all respect and equipped with all essential avionics/equipment as prescribed by the CAAN, Government of Nepal for conducting safe VIP flight Operations.
- 11. Specification/features of Helicopter (like Speed, minimum high altitude capability, Speed, VFR, IFR, AUW, FDR, CVR, GPS, capability to land on temporary Helipad communication, navigation, Radio license, SMS, AC, Weather Radar, Cockpit etc.) should be as per standard approved by CAAN for 5 seater helicopter.
- 12. Service provider should ensure CAAN conformance for VVIP operation and should also ensure that pilots are qualified for flying VIPs as per CAAN norms.
- 13. Service provider shall ensure compliance of all requirements of Nepal Aircraft Rules, CAR, Circulars issued by the CAAN, Government of Nepal and adhere to all relevant guidelines issued from time to time for the safe operations of helicopter.
- 14. The PIC/ First officer should be in uniform during the day of flight.
- 15. The Service Provider shall ensure the helicopter is clean and tidy for all VIP operations.

16. **CONFIDENTIALITY:** The parties expressly agree that the contents and provisions of this agreement will be treated as strictly confidential, and that neither party will divulge or leak them to any third party without first getting the other's written consent to this agreement. This applies to information about or concerning aircraft operations, as well as other related information.

17. **TERMINATION:**

The empanelment shall be terminated by giving a notice under the following circumstances:

- i. If the operation of the Service provider must be stopped due to a government order.(immediate termination of empanelment)
- ii. If the Helicopter is involved in a serious accident and is written off completely and service provider do not have any other Helicopter .(immediate termination of empanelment)
- iii. If SAPDC is unsatisfied with the services (With two months notice, the empanelment will be terminated.)
- iv. If the conditions are caused by acts of God, such as natural calamities, riots or other such situations over which there is no control, the empanelment will be immediately terminated.
- v. The service provider may terminate the empanelment by giving SAPDC a three-month written notice. If the company fails to give SAPDC three months notice before terminating the empanelment, SAPDC will seize the security deposit.
- vi. If the service provider closes their business, the service provider must give SAPDC a 1 month written notice before terminating the empanelment. SAPDC will seize the security deposit in case of non-compliance.
